**CUSTOM MANUFACTURING TERMS - Option "A"**

(Customer ***Exclusive Option*** – for someone wanting their own stamp line in production)

1. The Customer has ***exclusive*** rights to selling the manufactured stamp(s) **unless otherwise noted**
2. Image(s) submitted are subject to acceptance by Frog's Whiskers Ink (FWI).
3. **Set-up** charge is \$ 20.00 per submitted group.
4. Image(s) are to be clean and production ready @ min 600dpi, BW or Grayscale, jpg or tiff, otherwise custom artwork charge is \$45.00 per hour for cleanup and preparation.
5. **Plate Master(s)** are billed using ***Current Price Guide Chart*** and are sized, priced and labeled according to the standard FWI practice for stamp production.  
**Plate Master** pricing includes the 1<sup>st</sup> **Matrix Board** for production.
6. When necessary a worn, broken or damaged **Matrix Board** will be replaced using the customer's **Plate Master** and charged at current **Matrix Board** pricing,
7. The **Image, Matrix Board** and **Plate Master** is the property of the customer ***unless otherwise noted***. They may be stored by FWI or held by the customer. (*Who would deliver it to us if a new matrix board were required.*)
8. Customer is required to purchase first production run at a minimum of 50 units per manufactured stamp, with minimum 2 per image required purchase thereafter, at standard FWI prices.  
(*Special Pricing is offered at 100 units per item per order*)
9. Orders will be manufactured on first in, equals first out basis.
10. **RUSH** orders will be subject to additional fees.
11. All stamps will be manufactured using the same materials and are guaranteed to be of equal quality as the FWI line
12. When production is to discontinue by Customer or FWI, all inventories on hand (part or fully completed) will be billed out and all customer property held by FWI will be shipped to customer, **at customer's expense** prior to shipment.
13. If failure of Customer to pay for expenses owing under Option "A" line 12 occurs...then all inventories on hand (part or fully completed) and all customer property held by FWI will become the property & ownership of FWI.
14. Prices are subject to change with market fluctuations.

17. Image(s) are to be clean and production ready @ min 600dpi, BW or Grayscale, jpg or tiff,
18. The **Image, Matrix Board** and **Plate Master** is the property of FWI **unless otherwise noted**.
19. Customer is required to purchase first production run at a minimum of 50 units per manufactured stamp, with minimum 2 per image required purchase thereafter, at standard FWI prices.  
(*Special Pricing is offered at 100 units per item per order*)
20. Orders will be manufactured on first in, equals first out basis.
